

**GUN'S E-Z OWN SALES, INC.**  
**Rental Contract**

Gun's E-Z Own Sales, Inc. hereinafter referred to as Company.

Items Rented are itemized on attached invoice.

**Terms and Conditions**

1. Title: Items rented are the property of Company. Renter cannot acquire ownership of, equity in or title to items rented.
2. This Contract cannot be converted to a sales contract. Payments made under this Contract cannot be used, in whole or in part, for the purchase of Items Rented.
3. Renter promises to pay the following Rental Fee which does not include the initial fees set forth on the original invoice:  
Rent \$ \_\_\_\_\_ plus Sales Tax \$ \_\_\_\_\_ for a total Rental Fee of \$ \_\_\_\_\_ due on the \_\_\_\_\_ of each (week, month). The Renter acknowledges all Rental Payments plus sales tax must be paid by the due date until Rental is complete and the items being rented are returned to the company. Renter promises to pay a fee of \$10.00 if the above total Rental Fee is not paid within ten days of the payment due date.
4. Return of Items Rented: Items Rented must be returned to Company on or before the ending date. Renter agrees to provide 1-week notice for pickup of rented property. Renter also agrees to have a responsible key holder present at time of scheduled pickup to allow entry and verify the return of Items Rented. Failure to oblige with scheduled pickup will result in an additional \$20 trip charge.
5. Late Returns: If Renter does not return Items Rented by the Ending Date, Renter agrees to pay Company full Rental Rate plus sales tax for an additional period or periods until Items Rented are returned to Company. This clause does not grant Renter any right to extend this Rental Contract without the consent of Company.
6. Warranty: Items Rented are suitable for the normal personal household uses for which they were manufactured. They are free of damage unless noted by Company on the attached invoice.
7. Damage or loss: Renter promises to return all Items Rented and all manuals, parts and accessories of Items Rented free from any damage. Any Damage or loss of any Item Rented, including manuals and accessories of Items Rented, will be the responsibility of Renter. Should Items Rented be damaged or lost, Renter agrees to pay for the repair or replacement of Items Rented and manuals and accessories of Items Rented. Repair or replacement will be at the discretion of Company. Renter will not be responsible for damage noted by Company on the attached invoice.
8. Should Renter fail to perform on any of the Terms and Conditions of this Contract, Renter agrees to allow the Company to run the below credit card for all costs Company incurs to enforce the terms of this Contract or to recover Items Rented under this Contract. Cost can include but are not limited to unpaid rental fees, replacement of property, repair of property, past due fees, self-help repossession expenses, court fees, other collection fees and attorney fees. The Renter gives permission to the company to run the following credit card when the agreed upon terms are not met by the Renter.
